# TECHNICAL ANALYSIS OF SELECTED COMPANIES IN INDIA

### **ABSTRACT**

Technical analysis is the forecasting of future financial price movements based on an examination of past price movements. Technical analysis does not result in absolute predictions about the future with regard to forecasting. Instead, technical analysis can help investors anticipate what is "possible" to happen to prices over time. Technical analysis is the study of predicting prices of securities for future. The main aim is to generate returns by deciding when to enter and when to exit in the security. Technical analysis is related to the stock market considering factors affecting the supply and demand of stocks. It helps in understanding the intrinsic value of shares and knowing whether shares are undervalued or overvalued. The stock market indicators would help the investors to identify major market turning points. This is a significant part of technical analysis of companies which helps to understand the behavior of the shares, the signals given by them and the major turning points of the market price. This report aims at carrying out technical analysis of the securities of the selected companies and to assist investment decisions in the Indian market.

#### INTRODUCTION

Technical analysis can be defined as an art and science of forecasting future prices based on an examination of the past prices movements. Technical analysis is not astrology for predicting prices, it is based on analyzing current demand supply of commodities, stocks, indices, futures, or any tradable instrument. Technical analysis involves putting stock information like prices, volumes and open interest on a chart and applying various patterns and indicators to it; in order to access the future price movements. The time frame in which technical analysis is applied may range from intraday, daily, weekly, or monthly price data to many years. There are essentially two methods of analyzing investment opportunities in the security market; through fundamental analysis and technical analysis. Fundamental analysis uses information of financial and non-financial aspects of the company, while technical analysis uses information which ignores

fundamentals and focuses on actual price movements. Technical analysis assumes that price fluctuations are 90 percent psychological and 10 percent logical.

#### LITERATURE REVIEW

Several studies have been carried out to apply technical analysis in various financial markets

Kavajecz & odders white (2004) shows that support and resistance levels coincide with peaks in depth on the limit order book 1 and moving average forecasts reveal information about the relative position of depth on the book. They also show that these relationships stem from technical rules locating depth already in place on the order limit order book. Frankel and Froot (1990) analyzed technical analysis in forecasting the market. The guiding principle of technical analysis is to identify and go along with the trend. When there is a trend, whether started by random or fundamental factors, technical factors will tend to generate signals in the same direction. This reinforces the original trend, especially when many investors rely on the technical indicators. Thus, even if the original trend were a random occurrence, the subsequent prediction made by the technical indicator could be self-fulfilling. This nature leads to the formation of speculative bubbles. Lui & Mole (1998) examined fundamental and technical analysis by foreign exchange dealers in Hong Kong. They found that over 85% of the respondents rely on both methods and again technical analysis was more popular at shorter time horizons.

### **OBJECTIVES**

- To study the relevance of technical analysis in Indian capital market.
- To analyze the performance of selected companies in Indian stock market and to predict the future trends in the share prices through technical analysis.
- To find out risk and return for selected securities.
- To study technical analysis of selected stocks and interpret on whether to buy or sell.
- To aid the investors in making investment decision in selected stock.

### RESEARCH METHODOLOGY

The study aims at analyzing the price movements of selected company's scrip. As the study describes the existing facts and figures given in the financial statements and the price movements of the selected companies, the research design followed is descriptive and analytical in nature. The selected companies are: TATA STEEL ITC, GAIL, VEDANTA, YES BANK, ONGC, NTPC, POWER GRID, SBI,LARSEN AND TOUBRO, IOC, MASS FINANCIAL SERVICES, WIPRO, INFOSYS, SUN PHARMA. The period of the study is taken from October 2017 to April 2018. The major tools and techniques used in this study are: Volume, Stock (candle stick)

- This study can be used only for short term decision making.


# **Chart Analysis & Interpretations: -**

Candlestick chart and Line chart have been developed to analyze the fifteen selected companies with regard to their fluctuations and their connotation to the investors.

#### TATA STEEL

In the above chart, the price is located above the 12 & 26 days MACD. The chart represents the variation in different price such as open, high, low and close in respect to weeks which had been taken into consideration, from last 3 months. This chart shows RSI is 46.53. According to RSI analysis, Tata steel just got above its resistance level and is showing good signal. MACD is -3.2451 and Signal Line is -2.4341. So, according to MACD analysis, Tata steel is fair valued.

**Recommendations: -** Short Term Bullish.

**ITC:** *-ITC* Limited, a multi-business conglomerate, has diversified presence in FMCG, Hotels, Paperboards and Packaging, Agri-Business and Information Technology. The FMCG portfolio includes Packaged Foods, Branded Apparel, Personal Care, Education, Stationery and other FMCG products.

### **CHART 2: STOCK PRICE VARIATION OF ITC**



From the above chart, we can see the price variation of stock of ITC. According to simple moving average analysis, ITC is in an uptrend. Support level is at 272. According to Bollinger bands, ITC has hit the upper band which is a positive signal. The MACD is -0.4559 and Signal Line is -1.2341. According to MACD analysis, ITC is undervalued.

Recommendations: - Short and medium term Bullish.

#### GAIL: -

Gail (India) Limited (GAIL) (formerly known as Gas Authority of India Limited) is the largest state-owned natural gas processing and distribution company in India. It is headquartered in New Delhi. It has the following business segments: natural gas, liquid hydrocarbon, liquefied petroleum gas transmission, petrochemical, city gas distribution, exploration and production, GAILTEL and electricity generation.

From the above chart, we can see the price variations of stock of GAIL. The candle stick chart of GAIL shows long term bullish trend. Bollinger band shows that the price level of the stock has crossed the median level so this is good time to purchase the stock. Trade volume is consistent from the last month, so it also supports the price of stock. But the RSI is 51.96. So, GAIL is technically weak. So, it is suggested for an investor to wait for some time.

#### Recommendations: -

Wait up to 1 to 2 weeks, then take decision to buy for short time.

### **VEDANTA: -**

**Vedanta Limited**, formerly known as **Sesa Sterlite/Sesa Goa Limited**. Vedanta Group of companies is one of the world's largest global diversified natural resource majors, with operations across zinc-lead-silver, oil & gas, iron ore, copper, aluminum and commercial power.

From the above chart, we can see the open, high, low, close price of this stock.

RSI is 28.285. So, according to RSI analysis, Vedanta just got above its resistance level and is showing good signal. Volume is also supporting the price movement of this particular stock, so it is good sign to buy this stock.

Bollinger bandwidth suggests that a squeeze has ended and a breakout above the upper band has happened which is a positive signal. %b is 1.04. According to Bollinger bands, Vedanta has hit the upper band which is a positive signal.

Recommendations: - Short and long term Bullish.

From the above chart, we can say that the current price of the stock has crossed the medium limit of six months' periods. Volume is also supporting the price of the stock.

From the above chart, we can say that price just got above its 14-day simple moving average which is a positive signal. According to Bollinger Bands, ONGC is technically strong. RSI is 52.341 so, according to RSI analysis, ONGC is marginally strong.
